2. Resident guest, park fee \$5.00 for one week with necessary vaccination forms and Oak Run temporary tag
3. Yearly fees are non-refundable and are not prorated, except when coordinating vaccinations with registration.
4. Resident must agree to and sign: Waiver, Release of All Claims and Indemnification Agreement.

## OAK RUN DOG PARK WAIVER, RELEASE OF ALL CLAIMS AND INDEMNIFICATION AGREEMENT

PLEASE READ THIS FORM CAREFULLY AND BE AWARE THAT IN CONSIDERATION FOR PERMISSION TO USE THIS FACILITY, YOU WILL BE EXPRESSLY ASSUMING THE RISK AND LEGAL LIABILITY, WAIVING AND RELEASING OF ALL CLAIMS FOR INJURIES, DAMAGES OR LOSS WHICH YOU, YOUR DOGS AND OTHERS MIGHT SUSTAIN AS A RESULT OF PARTICIPATING IN ANY AND ALL ACTIVITIES CONNECTED WITH AND ASSOCIATED WITH THE USE OF THIS FACILITY AND SURROUNDING AREA.

I understand that I am solely responsible for supervising my dogs and determining whether this is an appropriate activity for them. I further understand that I am participating in this activity at my own risk (and risk of my dogs and others). In consideration of receiving dog park privileges for myself, the dogs identified in this application, and others, I hereby represent and warrant as follows: my dogs are licensed and are current with the required vaccinations and are spayed/neutered; my dogs' medical information is true and accurate for the dogs identified in this application; and I agree to the provisions set forth below. I further understand that providing false information or breaching any of the conditions or rules may result in the revocation of dog park privileges.

I acknowledge the following. Dog activities are intended to provide a fun and rewarding experience for me and my dogs. Despite careful and proper preparation, instruction, medical advice, conditioning and equipment, there is still a risk of serious injury, including death to the dog, its owner/handler or other persons or animals. Dogs are pack animals and when "off lead," even the best trained dogs will act instinctively. Understandably, not all hazards and dangers associated with dog activities can be foreseen. Certain inherent risks include the propensity of any dog to behave in dangerous ways that may result in injury to me another person, my dog or another dog. Other risks include, without limitation, the inexperience, negligence or irresponsibility of a dog owner/handler; the inability to predict a dog's reaction to movement, sounds, objects, persons, or other animals; and actions by the dog due to fright, anger, stress, insect bites or natural reactions such as jumping, pulling, resisting and biting; and hazards associated with environmental and traffic conditions, acts of God, inclement weather, slips and falls, premises defects, equipment failure, failure in instruction/supervision, and all other circumstances inherent to dog and/or outdoor activities. Further, should I attempt to break up a dog fight or restrain a dog, including but not limited to my dog, I may be severely mauled and/or attacked by my dog or other dogs or another dog's owner/handler.

I recognize that it is impossible for Oak Run Associates, LTD, ORHA (Oak Run Homeowner's Association), or others to guarantee absolute safety. I recognize and acknowledge that there are certain risks of physical injury to the dogs and their owners in participating in dog activities and I voluntarily agree, on behalf of myself, my dog(s) and any others who accompany me to the facility, to assume the full risk of any injuries, damages or loss, regardless of severity, that I, my dogs or others might sustain as a result of participating in any and all activities connected with or

associated with use of this facility and surrounding area. I understand that the dog park is self-directed and not continually supervised by any agent or employee of the Oak Run Associates, LTD. I assume all risks associated with using the dog park, including its fixtures and equipment, in an unsupervised and self-directed manner. I acknowledge that Oak Run Associates, LTD makes no guarantee that all dogs in the dog park are vaccinated, nor can it guarantee that children under the age of 10 will not gain access or behave appropriately. Further, Oak Run Associates, LTD has no knowledge about the behavior and temperament of the dogs using the area. Moreover, Oak Run Associates, LTD, cannot guarantee that all dog handlers or dogs, for that matter, will comply with the rules and regulations that govern use of the facility. I do hereby agree to waive, relinquish, release and forever discharge Oak Run Associates, LTD, ORHA (Oak Run Homeowner's Association), Dog Park Committee, their volunteers and the Ghumman family, including any officials, agents, volunteers or employees of any of the foregoing, from any and all claims for injuries, damages or loss that I, my dogs, or others may have or which may accrue to me, my dogs, or others and arising out of, connected with, or in any way associate with the use of this facility and surrounding areas, including any such claims that may arise out of the negligence of any of the releasees.

I further agree to indemnify and hold harmless and defend Oak Run Associates, LTD, ORHA (Oak Run Homeowner's Association), Dog Park Committee, their volunteers and the Ghumman family, and any officials, agents, volunteers and employees of the foregoing from and against any and all losses, claims, damages, liabilities, causes of actions and expenses (including attorney fees), on account of personal injuries or death to any person (including me and others) or dogs (including my dog) or damages to property occurring, growing out of, incident to, or resulting directly or indirectly from my use of this facility and surrounding areas or the actions of me or others (including dogs) using this facility and surrounding areas, including any such personal injuries or death that may arise out of the negligence of any of the indemnities.

I HAVE READ AND FULLY UNDERSTAND THE ABOVE IMPORTANT INFORMATION, WARNING OF RISK, ASSUMPTION OF RISK AND WAIVER AND RELEASE OF ALL CLAIMS. A DIGITAL OR FACSIMILE SIGNATURE SHALL SUBSTITUTE FOR AND HAVE THE SAME LEGAL EFFECT AS AN ORIGINAL FORM.

Everyone who enters Thatcher Dog Park must have a signed Liability Waiver on file.

# THATCHER PARK RULES & REGULATIONS

Hours: 7 am to Sunset, except Tuesday mornings. The park is closed from sunset Monday until noon on Tuesday for park maintenance. If there is rain on Tuesday, the park will be closed on Thursday morning until noon.

- 1) All Dogs must have current rabies and all other vaccinations as required by Marion County & Public Health Departments, be licensed and free from contagious diseases and parasites.
- 2) Dogs must be leashed when entering and leaving the park.
- 3) Dog owners are solely responsible for the actions and behavior of their dogs.
- 4) Please ensure dogs do not escape the fenced area.
- 5) Animals other than dogs are not allowed.
- 6) Owners must have a leash, ID, license and dog park tags at all times.
- 7) Dogs must always be in view of and within voice control of their owner.
- 8) Leash your dog and leave the park if aggressive behavior is observed.
- 9) Never leave your dog unattended.
- 10) Only spayed or neutered dogs allowed.
- 11) No puppies under 6 months of age.
- 12) **CLEAN UP AFTER YOUR DOG.** Fill any holes your dog may dig.
- 13) No children under 10 years of age allowed. Children over 10 must be closely supervised and behave appropriately. No running, shouting or petting other dogs without the owner's permission.
- 14) **NO FOOD OR BEVERAGES.** Water is permitted.
- 15) Hydrate regularly with water, but do not leave bottles in the trash cans.
- 16) Whatever you bring into the park, take back home with you.
- 17) **NO SMOKING**
- 18) No bicycles, skateboards, rollerblades, hover boards, scooters or motorized vehicles allowed, except those necessary for the disabled.
- 19) No bare feet.
- 20) Dogs with a known history of dangerous or aggressive behavior are prohibited.
- 21) Owners are responsible to treat their dogs for fleas and ticks.
- 22) Everyone who enters must have a signed Liability Waiver on file.
